Trip Cancellation: Provides benefits up to the Maximum Benefit Amount shown in the Schedule of Benefits, to reimburse You for unused non-refundable Prepaid Payments You paid for Travel Arrangements when You are prevented from taking Your Trip due to a covered reason.

Trip Interruption: If You must start Your Trip late or are unable to complete Your Trip, this Benefit will reimburse You, up to the Maximum Benefit Amount shown in the Schedule of Benefits, for the unused, forfeited, prepaid non-refundable Payments or Deposits paid for the land or water Travel Arrangements You purchased for Your Trip plus the Additional Transportation Cost paid to: a) join Your Trip if You must depart after Your Scheduled Departure Date or travel via alternate travel arrangements; or b) rejoin Your Trip from the point where You interrupted Your Trip to the next Scheduled Destination; or c) transport You to Your originally scheduled Return Destination of Your Trip. Trip Interruption must occur while coverage is in effect for You due to any of the covered Unforeseen reasons.

Trip Delay: Reimburses you up to the Maximum Benefit Amount shown in the Schedule of Benefits, for the unused, forfeited, prepaid non-refundable Payments or Deposits for the Travel Arrangements, Reasonable Additional Expenses, plus the Additional Transportation Cost paid if Your Trip is delayed at least 6 consecutive hours from the original departure time and this prevents you from reaching your scheduled destination.

Medical Evacuation and Repatriation of Remains: Among other things, this reimburses transportation expenses incurred to transport you to the nearest suitable medical facility where treatment is available if you incur a sickness or injury that is acute, severe, or life threatening if adequate treatment is not available in your immediate area.

Baggage and Personal Effects: Covers loss, theft, or damage of your baggage and personal effects.

Baggage Delay: Reimburses cost of the necessary personal items purchased on your trip if your checked baggage is delayed or misdirected by a Common Carrier for at least 12 consecutive hours or more from your time of arrival at a scheduled destination other than your return destination.

Emergency Accident & Sickness Medical Expense: Provides coverage if a covered accidental injury or sickness occurs during your trip.

Accident Death and Dismemberment: Coverage for loss of life or dismemberment caused by an accident occurring during the trip.

Optional - Cancel for Any Reason (CFAR): If you cancel your trip for any reason not otherwise covered by this plan, this provides benefits for up to 75% of the trip cost provided your payment/deposit for this plan is received at or before the final payment for Your Trip, and you must cancel the trip 48 hours or more before scheduled departure date of your trip. Please note that you must pay an additional cost for this coverage and can only purchase this optional benefit at the time the protection plan is purchased.
